## **Executive Summary**

Pottstown Area Health & Wellness Foundation (PAHWF) invites nonprofit organizations and programs to apply for a competitive grant opportunity to support and bolster the health and wellness of Pottstown, PA residents.

In July 2003, the PAHWF was founded as the result of the sale of Pottstown Memorial Medical Center to Community Health Systems. PAHWF enhances the health and wellness of area residents, providing education, funding, and programs that provide equitable access and opportunities for all residents to adopt healthy lifestyles. It serves the residents of Pottstown Borough and those within a 10-mile radius of downtown Pottstown. Since 2003, PAHWF has awarded \$55M to area nonprofits and municipalities to support early childhood development, school programs, youth preparedness, parks and playgrounds, and healthcare access programs.

In 2022, PAHWF surveyed the community to gather information about the health and well-being of residents who live in neighborhoods with long-term disinvestment. Information obtained from the survey informed PAHWF's community response which includes a participatory grantmaking process. This participatory grant, the Pottstown Community Voices Grant Fund (PCVGF) will be overseen by an advisory council comprised of Pottstown residents who will review and grant \$100,000 to address community needs highlighted in the community survey.

This participatory grantmaking process is intended to empower community residents by giving them the ability to invest in solutions that will impact their own neighborhoods and neighbors.

#### **OVERVIEW**

The Pottstown Community Voices Grant Fund (PCVGF) will provide funding that focuses on solutions to long-term disinvestment within specific areas of Pottstown. A PCVGF Advisory Council comprised of Pottstown community members will review and evaluate all applications and recommend grant funding decisions to PAHWF. A total amount of \$100,000 will be awarded in 2024.

#### FOCUS AREAS AND COMMUNITY SOLUTIONS

PAHWF convened two groups of community members in the summer of 2023 which included adults and youth participants. These community conversations allowed the residents to identify several key focus areas that will be prioritized for the first year of funding. The PCVGP aims to support the health and well-being of the community by investing in programs/projects that affect residents in one or all of the following ways:

- Access to Parks/Recreation/Green Spaces
- Positive Mental Health Solutions
- Neighborhood Safety and Security
- Housing
- Eliminating Barriers to Employment

Community members offered insights and ideas on ways that grantees can address the focus areas. These solutions are listed below (bulleted list in each focus area) and while the council welcomes all grant applications that impact the focus areas, attention will be paid to any solution that addresses one or more of the ideas brought forth by community members.

#### **Access to Parks/Recreation/Green Spaces**

When residents have safe access to open spaces, parks, and recreational activities, health and well-being are promoted. Additionally, a community is built when individuals from diverse backgrounds come together in common places and spaces.

- Access to parks, natural lands, and open spaces including water access
- Expand activities that are available for adults
- Recreation and exercise opportunities for youth
- Support for physical spaces that invite all community members to come together (parks, community centers)

#### **Positive Mental Health Solutions**

Improving the mental health of residents directly influences positive quality of life outcomes.

- Increasing access to mental health care
- Holistic approaches to promote mental wellness
- Community building programs and initiatives to support positive social connections
- Youth programs for positive mental health development
- Mental health programs and resources for parents

#### **Neighborhood Safety**

When residents don't feel safe in the community in which they live, they cannot thrive. Neighborhood safety is a fundamental aspect of the health and well-being of a community.

- Programs that address gun violence
- Programs that support youth violence prevention
- Physical infrastructure improvements including street lighting and the lighting of alleyways, street improvements, the repair of walkways, additional fencing, sidewalk repair, litter clean up
- Programs that build positive connections with law enforcement

#### Housing

Belonging to a healthy community includes the ability to live and thrive in a place you call home.

- Long-term (non-emergency) support for renters/homeowners
- Lead / Asbestos removal initiatives
- Programs that help homeowners with repair projects and ongoing maintenance (pest control, window repair, HVAC)
- Programs that increase pathways to home ownership
- Innovative solutions for increasing affordable housing

#### **Eliminating Barriers to Employment**

Productive, meaningful employment that provides a living wage is essential to leading a healthy life. By eliminating barriers to employment, the community promotes its own health and well-being and sees positive upward mobility for all.

- Mentorship & educational support for youth
- Internships
- Hard and soft skills development programs
- Entrepreneurial investment

#### GEOGRAPHIC FOCUS AREA

The focus of this competitive grant opportunity is to provide programs and services that will directly affect neighborhoods in Pottstown with historic disinvestment. The Census Block Groups that participated in the 2022 Pottstown Community Survey are highlighted on the map in Appendix A. Grant applications should focus on these neighborhoods and their residents. Applicants will be asked to explain how their proposed program/project will create meaningful change in these communities.

#### **USE OF FUNDS**

The PCVGF is interested in funding programs and projects that are solutions-based. As such, funds are provided for organizations whose outcomes impact the specific focus areas and can clearly articulate how residents will benefit.

#### KEY CHARACTERISTICS OF A QUALITY APPLICANT

Quality applicants should be able to demonstrate that they possess the following attributes:

- They are committed to a thriving, healthy, successful future for Pottstown
- They are committed to collaborations and partnerships within the community
- They are representative of the communities they serve
- They are informed by the community and invested in community participation

#### AWARDS AND SELECTION PROCESS

A total amount of \$100,000 will be awarded through the PCVGF grantmaking process. Applicants can request up to \$15,000. Applicants can only submit one request per organization.

The PCVGF Advisory Council made up of Pottstown residents will oversee the grantmaking decision process. All applicants will be screened for eligibility and focus alignment. Qualified applications will proceed to the full Council for review using a scoring rubric (outlined in Appendix B). Applications scoring the highest will be discussed and voted on by the Council for funding.

#### **TIMELINE**

Applications will be accepted from February 1, 2024, to March 1, 2024. All applications must be submitted via the online application portal by Friday, March 1, 11:59 p.m. EST. Please access the application portal early to avoid any last-minute issues.

The PCVGF Advisory Council will review applications from March through May 2024.

Grant awards will be announced in June 2024.

The grant period begins July 1, 2024, and ends June 30, 2025.

#### REPORTING REQUIREMENTS

Grantees will be required to check in with a PCVGF Advisory Council in lieu of a mid-term report.

Grantees will be required to attend an end of the grant term meeting to participate in an interactive conversation with the PCVGF Advisory Council including an update on the impact of grant funding.

#### **ELIGIBILITY AND PRIORITIES**

Organizations do not have to be located within the geographic focus area to be eligible for a grant, but the program/project to be funded must serve geographic focus area residents (Appendix A). Priority will be given to organizations that apply for solutions-based awards that directly solve one or more of the specific issues/ideas proposed by community members.

#### 501c3 STATUS

PAHWF serves non-profit organizations with tax-exempt status in good standing with the IRS, which strive to promote priorities that are in line with their mission. Organizations applying for these competitive grants must be 501(c)(3) organizations and will be required to submit their Employer Identification Number (EIN) to verify their status. See below for a full list of documents that must be submitted with each grant application.


